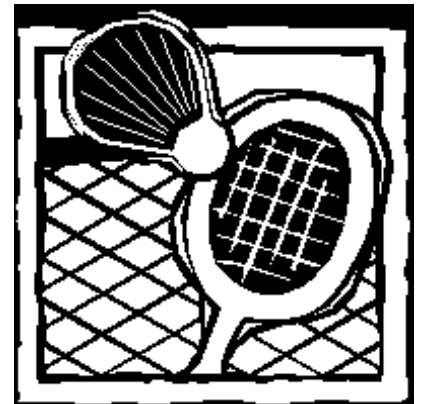

The Pleasant Hill Recreation & Park District is announcing its **2009 Summer** Adult 5-on-5 Basketball season.

The leagues are set-up for competitive play but the overall goal is enjoyable participation for all. The District does not offer professional leagues. The main emphasis of the league is the recreational elements including the fun, enjoyment, good sportsmanship, and friendships that are developed.

No registration packets will be accepted after **May 28**. *There are no refunds once a team is placed in a league. If league(s) are cancelled money will be refunded.*

Any incomplete item in your packet (e.g. missing team or player information, and/or incomplete payment) can result in the entire packet being rejected – thereby losing priority for team entry into the league. Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT ON TEAM PLACEMENT.

The District will not contact your team regarding their acceptance into the league unless your team was not accepted or moved to a different league than you registered for.

ROSTERS:

New – Starting Winter 2009 season, each team will complete one roster per year. The players on a 2009 team roster will be valid for the entire 2009 calendar year.

Enclosed are payment coupons for each team representative to use for each season the team plays.

Each player's information must be complete: players name, address, phone number, driver's license number and signature. If information is left out or your check bounces, the packet can be declared incomplete.

Roster additions and deletions must be made before 5:00 pm, Monday through Friday prior to your game. This must be done at the Administrative Office or by mail with the League's "Add/Drop Form" (gym supervisors & scorekeepers do not handle roster additions or deletions). An added player may not use a dropped player's non-resident fee after **July 9**. Roster additions must be made prior to the ninth game being played. Teams may carry a maximum of fourteen (14) players on their roster. **Only players on the roster may participate.**

All games are held at Pleasant Hill Education Center at One Santa Barbara Road. Teams officiate their own games.
