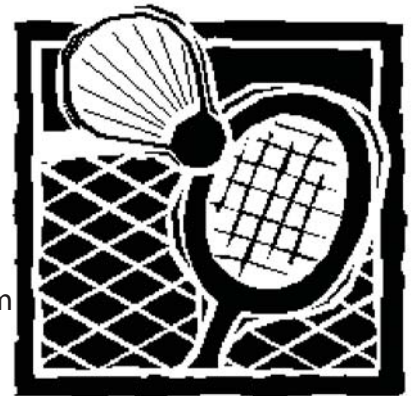

## Adult 5-on-5 Basketball League – Winter/Spring 2012

The 2012 Spring Season will begin on February 19 and run through April. 8 weeks of play.

One of the goals of the Pleasant Hill Recreation & Park District is to provide organized recreational opportunities for people of all ages. The leagues are set-up for competitive play but the overall goal is enjoyable participation for all. The District does not offer professional leagues. The main emphasis of the league is the recreational elements including the fun, enjoyment, good sportsmanship, and friendships that are developed.

\*NR = Non-Resident. Each player not living in the PH District must pay an additional fee of \$14. A maximum of 3 non-residents are charged per team.

No registration packets will be accepted after **January 23**. *There are no refunds once a team is placed in a league. If league(s) are cancelled money will be refunded.*

Returning teams are those which participated in our **2012 Winter, 2011 Summer, 2011 Spring** seasons with a minimum of 51% of the former team's roster. Teams that do not meet those requirements will be processed as new teams.

The District will not contact your team regarding their acceptance into the league unless your team was not accepted or moved to a different league than you registered for.

### ROSTERS:

Each player's information must be complete: players name, address, phone number, driver's license number and signature. If information is left out or your check bounces, the packet can be declared incomplete. Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT ON TEAM PLACEMENT.

Roster additions and deletions must be made before 5:00 pm, Monday through Friday prior to your game at the Administrative Office or by mail with the League's "Add/Drop Form" (gym supervisors & scorekeepers do not handle roster additions or deletions An added player may not use a dropped player's non-resident fee after **January 23**. Roster additions must be made prior to the ninth game being played. Teams may carry a maximum of fourteen (14) players on their roster. **Only players on the roster may participate.**
