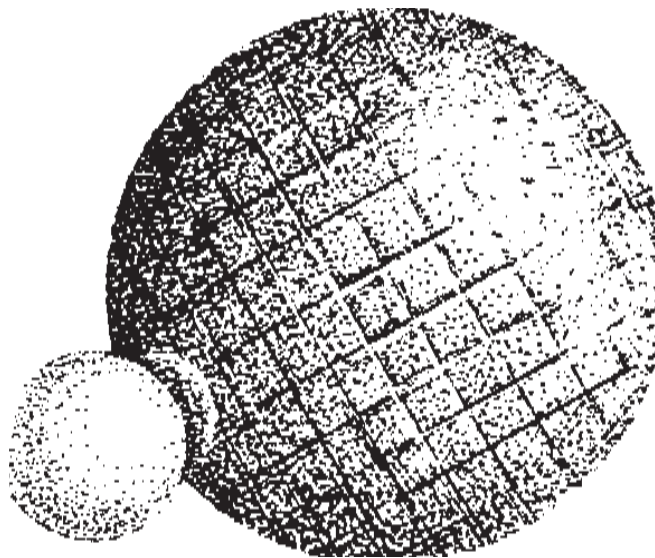

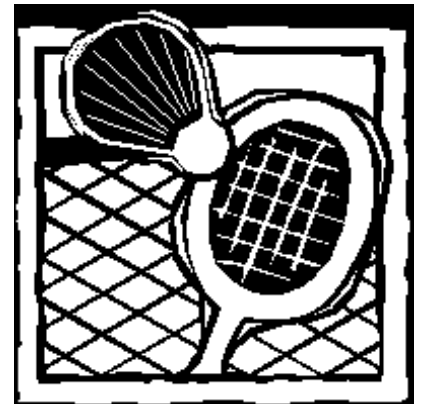

The Pleasant Hill Recreation & Park District is announcing its 2010 Fall Boccé League. Invite your friends and family to join the fall bocce fun! Teams will play once per week however, those games could fall on any evening during the week (Monday-Friday). The schedule will have all teams playing on each night of the week during the season.

The District will not contact your team regarding their acceptance into the league unless; your team was not accepted.

The season will consist of a **seven (7)** match schedule followed by single elimination play-offs. The exact number of games will be dictated by the number of teams in the league and decisions made at the team representative's meeting. Teams are responsible for preparing the courts prior to their matches.

#### **THE GAME OF BOCCÉ:**

Boccé is played with eight large boccé balls and one small target ball called the "pallino." The object of the game is to roll the boccé ball closest to the pallino. There are two balls per person and four players making up a team. Two players from each team are permanently stationed at each end of the court for the game. A game consists of twelve (12) points. The best of three games constitutes the winner of the match.

---

#### **PHILOSOPHY:**

One of the goals of the Pleasant Hill Recreation & Park District is to provide recreational opportunities for people of all ages. The Adult Boccé League provides the community with an opportunity to participate in an organized sports activity. The leagues are set-up for competitive play but the overall goal is enjoyable participation for all. The District is not offering professional leagues. **The main emphasis of the league is the recreational elements including the fun, enjoyment, good sportsmanship, and friendships that are developed.**

Priority for filling the spots in the league will be on a first received, first placed basis with returning teams getting priority over new teams. New and returning teams are encouraged to turn their packets in well before their registration deadlines. No registration packets will be accepted after **September 17**. **There are no refunds once a team is placed in a league.** If league(s) are cancelled money will be refunded.

Returning teams are those that participated in our **2010 Summer, 2010 Spring or 2009 Fall** Adult Boccé Seasons with a minimum of 51% of the former team's roster. Teams that do not meet those requirements will be processed as new teams.

The District will not contact your team regarding their acceptance into the league unless; your team was not accepted. *Please note: We can only accept 28 teams for the league.*

Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT ON TEAM PLACEMENT.

**ROSTERS:**

Be sure all information is completed on the roster including each players name, address, phone number, drivers license number and signature. If information is left out, the packet will be declared incomplete.

Roster additions and deletions must be made before 5:00 pm, Monday through Friday, at the Administration Office prior to your game, or by mail using the League's Roster Add Form. We DO NOT accept faxed Roster Addition forms. An added player may not use a dropped player's non-resident fee after **October 11**. Roster additions must be made prior to the second to last match of the season. No one may be added after the second to last match has been played. **Teams may carry a minimum of 4 players and maximum of sixteen (16) players on their roster. Only players on the roster may participate.**

**LEAGUE INFORMATION:**

The Fall league is scheduled to play on the following EVENINGS:

Monday, Tuesday, Wednesday, Thursday, Friday

NOTE: Teams may play on other nights not designated as above due to court availability, play-offs, makeup games, and/or size of a particular league. Remember, Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT on TEAM PLACEMENT and does not guarantee placement of any team.

League fees cover: The specified number of games, court rentals, boccé balls, league awards, and lighting.

Other pertinent rules, regulations, scheduling format and information will be discussed at the Annual Team Representatives meeting to be held **Tuesday, Sept 21, 8:00 pm, at the Pleasant Hill Recreation Administration Office, 147 Gregory Lane, Pleasant Hill. Everyone is required to attend the meeting.**
