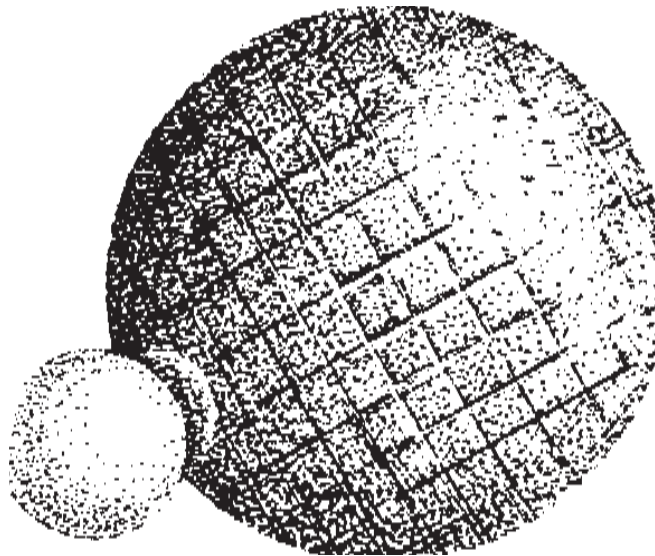

## ADULT BOCCÉ LEAGUE - 2012 SPRING SEASON

The season consists of a **ten (10)** match schedule followed by single elimination play-offs. The exact number of games will be dictated by the number of teams in the league and decisions made at the team representative's meeting. The season will begin play on March 15 and will run through June, and possibly into July.

\* NR=non-resident. Players not living in the PH District must pay an additional fee of **\$10.00. A maximum of 6 non-residents are charged per team.**

*\*There a maximum of 28 teams allowed in the league.*

Priority for filling the spots in the league will be on a first received, first placed basis. *Returning teams receive priority placement through **February 17. Once the league is full, no other packets will be taken.** There are no refunds once a team is placed in the league. If league(s) are cancelled money will be refunded. Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT ON TEAM PLACEMENT.*

Returning teams are those that participated in one of our **2011 Spring, 2011 Summer or 2011 Fall** Adult Boccé Seasons with a minimum of 51% of the former team's roster. Teams that do not meet those requirements will be processed as new teams.

The District will NOT contact your team regarding their acceptance into the league unless; your team was not accepted. *Please note: We can only accept 28 teams for the league.*

## **ROSTERS/ROSTER ADDITIONS:**

Be sure all player's information is complete on the roster. If information is left out, the packet can be declared incomplete – thereby losing priority for team entry into the league. Rosters must have a minimum of 6 players signed up in order to be accepted.

Roster additions must be made before 5:00 pm, Monday through Friday, at the Administration Office prior to your game, or by mail using the League's Roster Add Form. We DO NOT accept faxed Roster Addition forms. An added player may not use a dropped player's non-resident fee after **March 12**. Roster additions must be made prior to the second to last match of the season. No one may be added after the second to last match has been played. Teams may carry a minimum of 4 players and maximum of sixteen (16) players on their roster. Only players on the roster may participate.

## **LEAGUE INFORMATION:**

All teams are scheduled to play one night per week, varying different days each week.

- Evenings: Monday, Tuesday, Wednesday, Thursday, Friday, Saturday & Sunday.
- Weekend Afternoons: Saturday and/or Sunday

Teams are responsible for preparing the courts prior to their matches.

League fees cover: The specified number of games, court rentals, boccé balls, league awards, and lighting.

Other pertinent rules, regulations, and league information will be discussed at the Annual Team Representatives meeting **Tuesday, March 6, 6:00 pm, at the Boccé Courts at Rodgers-Smith Park, 736 Grayson Road, Pleasant Hill. Everyone is required to attend the meeting. (SEE ATTACHED FLYER!)**
