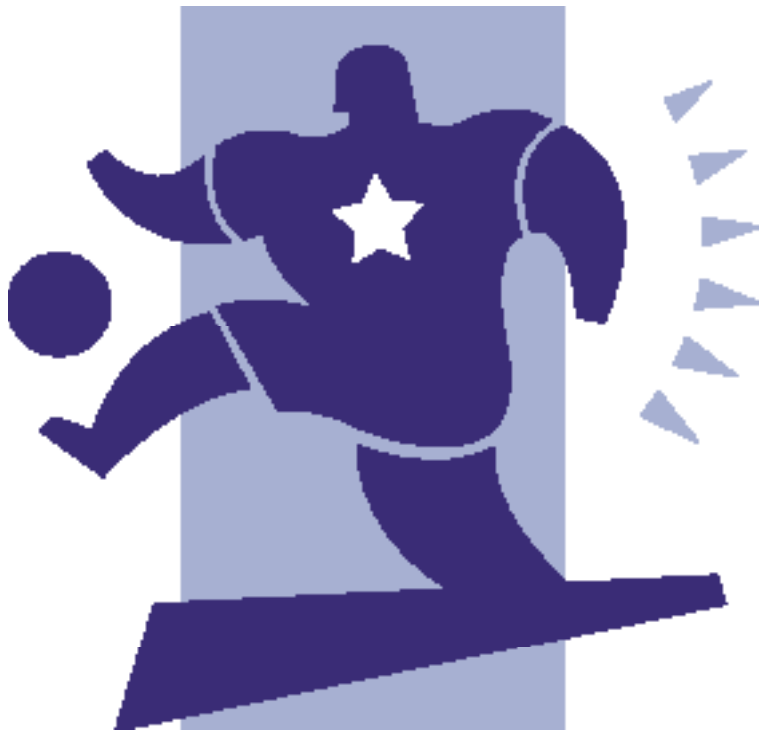

## ADULT KICKBALL LEAGUE — 2011 SPRING SEASON

The Spring Season will consist of a six (6) game schedule followed by single elimination play-offs. All games will be officiated by one umpire. The season will begin on March 23 and will run through May.

\* *NR= non-Resident. Each player not living in the PH District must pay an additional fee of \$5. A maximum of 7 non-residents are charged.*

### PHILOSOPHY

**Registration will not be accepted without payment.** Priority for filling the spots in the league will be on a first received, first placed basis. No registration packets will be accepted after March 11. *There are no refunds once a team is placed in a league. If league(s) are cancelled money will be refunded.*

## **ROSTERS:**

Be sure all information is complete on the roster including each players name, address, phone number, drivers license number and signature. If information is left out or your check bounces, the packet may be declared incomplete.

Roster additions must be made before 5:00 pm, Monday through Friday, prior to your game. This must be done at the Administrative Office or by mail with the League's "Add/Drop Form" (umpires and scorekeepers will not handle any additions or deletions). An added player may not use a dropped player's non-resident fee after **March 23**. Teams may carry a minimum of ten (10) and a maximum of twenty (20) players on their roster.

## **KICKBALL RULES:**

All rules, regulations, schedules and information will be discussed and handed out in a pamphlet at the team representatives meeting to be held **Tuesday, March 20, 6:15 pm, at Pleasant Hill Recreation & Park District Administration Office at 147 Gregory Lane, Pleasant Hill.** **All Team Representatives are Required to Attend the Meeting.**

## **LEAGUE INFORMATION:**

The league is scheduled to play on Friday nights.

NOTE: Teams may play on other nights not designated as above due to field availability, play-offs, makeup games, and/or size of a particular league. Remember, Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT on TEAM PLACEMENT and does not guarantee placement of any team.
