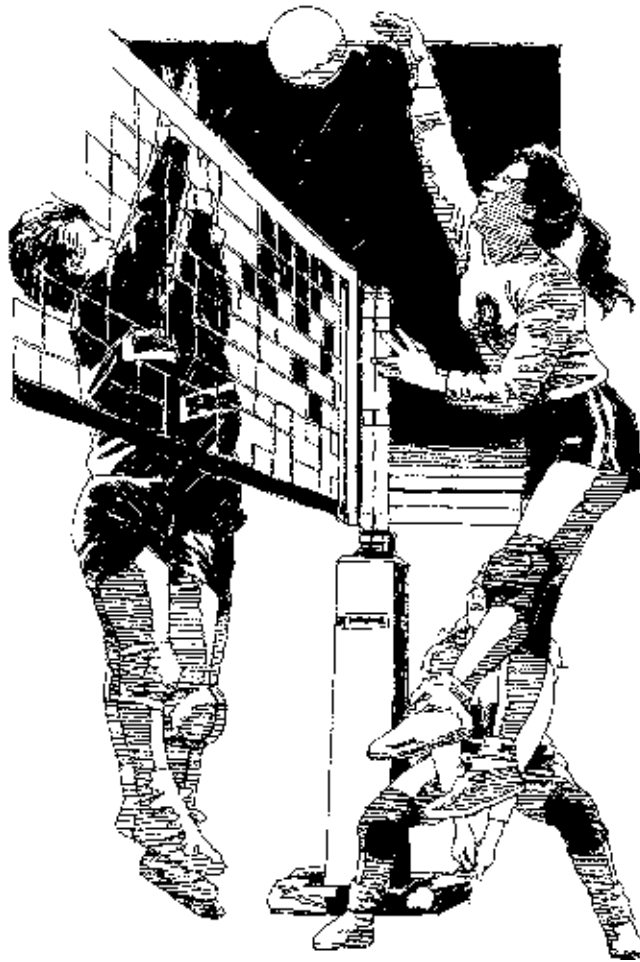

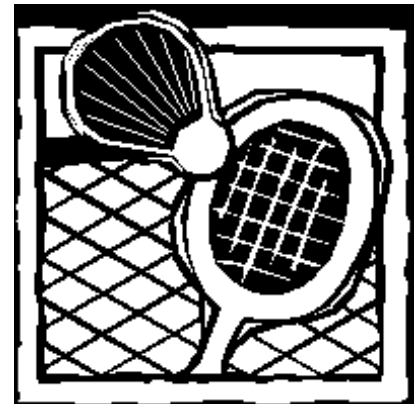

Pleasant Hill Recreation & Park District is pleased to announce their 2009 Summer Co-ed Volleyball Season. We are looking forward to the upcoming season and hope you are too.

Our Philosophy - One of the goals of the Pleasant Hill Recreation & Park District is to provide recreational opportunities for people of all ages. The Adult Co-ed Volleyball League provides the community with an opportunity to participate in an organized sports activity. The leagues are set-up for competitive play but the overall goal is enjoyable participation for all. The District is not offering professional or semi-professional leagues. The main emphasis of the league is the recreational elements including the fun, enjoyment, good sportsmanship, and friendships that are developed.

FEES:

*NR= non-resident. Each player not living in the District must pay an additional fee of **\$9**.

There is a maximum of three (3) non-residents charged per team.

The league will begin on July 6 and runs through September.

A percentage of your league and non-resident fees will be designated for improvements to comply with the American Disability Act.

Priority for filling the spots in the league will be on first received, first placed basis. Pleasant Hill Recreation & Park District reserves the right to make FINAL JUDGMENT ON TEAM PLACEMENT. ***There are no refunds once a team is placed in a league. If league(s) are cancelled money will be refunded.***

Returning teams are those which participated in our **2009 Winter, Spring** Adult Co-ed Volleyball Seasons with a minimum of 51% of the former team's roster. Teams that do not meet those requirements will be processed as new teams

The District will not contact your team regarding their acceptance into the league unless, your team was not accepted or moved to a different league than you registered for.

ROSTERS:

Each player's information must be complete: name, address, phone number, drivers license number and signature. If information is missing the roster can be declared incomplete and returned.

Roster additions and deletions must be made before **5:00 pm**, Monday through Friday, prior to your match. This can be done in person at the Administrative Office or by mail with the League's add/drop form. An added player may not use a dropped player's non-resident fee after **July 6**. Roster additions must be made prior to the **second to last** match of the season. No one may be added after the **second to last** match has been played.

MATCH TIMES AND LOCATIONS

Matches will be played on Monday evenings at the Pleasant Hill Education Center Gymnasium, One Santa Barbara Road. Match times are tentatively scheduled for **6:45, 8:00 & 9:15 pm**

The Volleyball League consists of a **seven to nine (7-9)** match schedule followed by single elimination play-offs. Number of matches determined on number of teams registered.

LEAGUE PROVIDES

The team and player fees cover the specified number of matches, game balls, nets, poles, weekly standings, team awards, gymnasium, and gym maintenance.

ABRIDGED LIST OF RULES:

The Pleasant Hill Recreation & Park District Adult Co-ed Volleyball League plays under the United State Volleyball Association's (U.S.V.B.A.) rules with some of the following exceptions.

A. PLAYERS:

1. Teams will play with no less than 4 nor more than 6 players on the court at any time.
2. There must be at least 2 women and 2 men on the court at all times.

3. There will be no more than 3 men nor 3 women on the court at any time.
4. A team may carry no more than 10 players on its roster.
5. There must be at least 3 males and 3 females on each roster.
6. If a team uses a player not on its roster, that match is forfeited.
7. **The Spring Season will be all reverse coed.**

B. MATCHES:

1. All games are to 15 points, with a maximum of 17 points.
2. The third game is a rally point game, with each serve resulting in a point.
3. The Winter season will be played under standard co-ed rules.

C. TIME OUTS:

1. Two time outs are allowed per team per game. Time outs are thirty seconds in length.
2. No time outs are allowed in the last fifteen (15) minutes of the match, regardless of the starting time of the match.
3. If a time out is called in violation of the above time out rules, a side out or point is awarded after a team has been given a warning.

D. OFFICIATING:

1. Your team must supply four persons to officiate: a head referee, umpire and two line persons/scorekeeper when scheduled.
2. Failure to provide the officials or start any game on time will result in forfeiture of the officiating teams first game of their next match. Failure to start any game within ten minutes of game start time will result in forfeiture of the officiating teams next match, except when "Rule A" is not met by the playing teams.

| <ol style="list-style-type: none">3. OFFICIAL'S TRAINING: Each <u>NEW</u> team is required to send <u>ALL</u> their rostered players to an Official's Training. New teams with three or more USVBA Certified Officials may petition the league to waive the training requirements. Copies of certification cards are required prior to the training and should be submitted with your roster. OFFICIAL'S TRAINING will be held the first night of league play on, <u>MONDAY, July 6th & July 13th, 2009, 6:45-8:15 pm</u>, at the Pleasant Hill Education Center Gymnasium. |
