### **ROSTERS / ROSTER CHANGES:**

**All teams must complete a 2017 team roster. Rosters cannot be carried over from year to year.** Please make sure all player information is complete: name, address, phone number and signature. If information is left out or your check bounces, the packet can be declared incomplete.

Roster changes must be made by 5:00 pm, Monday through Friday, prior to your game, at the District's Administrative Office with the League's "Add/Drop Form" (gym staff & scorekeepers do not handle roster changes). Roster additions must be made two weeks prior to the end of each season. Teams may carry a maximum of ten (10) players on their roster. **Only players on the team roster may participate.**
