### **ROSTERS / ROSTER CHANGES:**

**All teams must complete a 2017 team roster to play for the calendar year. Rosters cannot be carried over from year to year.** Please make sure all player information is complete: name, address, phone number, and signature. If information is left out or your check bounces, the packet can be declared incomplete.

Roster changes must be made by 5:00 pm, Monday through Friday prior to your game at the District's Administrative Office using the League's "Add/Drop Form" (gym supervisors & scorekeepers do not handle roster changes). Roster additions must be made two weeks prior end of regular season. Teams may carry a maximum of fourteen (14) players on their roster. **Only players on the roster may participate.**
