Be sure ALL information is completed on your roster. If information is left out the packet will be declared incomplete.

Returning teams are those that participated in one of our **2016 Spring, Summer or Fall** Boccé Seasons with a minimum of 51% of the former team's roster. Teams that do not meet those requirements will be processed as new teams.

Roster changes must be received at the District Office before 5:00 pm, Monday through Friday, prior to your game, using the League's "Roster Addition Form. An added player may not use a dropped player's non-resident fee after **March 13**. Teams may carry a minimum of 4 players and maximum of sixteen (16) players on their roster. Only players on the roster may participate.
